There were no corrections to the January 13, 2018 Sorority Meeting Minutes. A motion to adopt the Minutes as transmitted was made by Soror Marguerite S. Middleton and seconded by Soror Cheryl McWilliams. Motion carried.

OFFICER REPORTS

BASILEUS REPORT: Soror Gretchen B. Morgan

Gamma Xi Omega Chapter began the 2018 calendar year with much excitement. This chapter had excellent representation at the Emancipation Proclamation Day Parade on January 1st, at the MLK Day of Service Project on January 15th, and at the Low Country Aid to Africa event on January 27th. This is the time that the newly-set goals, based on our reflections, lessons, and experiences of the past year, will be put into place. As members of this chapter, your talents, expertise and opinions are valued and necessary, so that we can continue to impact the community in which we live. Young girls are looking for guidance and mentorship, families need educational opportunities, as well as opportunities that encourage healthy lifestyles and prevent diseases that disproportionately affect people of color. Violence is shattering the peace that should exist in our neighborhoods, which further indicates that there is still so much work to

be done. I implore you to keep that message in your hearts this year as we move to continue our service to all mankind.

2018 Chapter Tax

- On Monday, January 8, 2018, I received an email from Felicia Perkins (Membership Department) stating that the 2018 chapter tax had not been paid. It was further stated that the chapter tax should be submitted through the mass payment system with the first submission of per capita fees. Additionally, the email stated that financial cards for the chapter would not be mailed until the 2018 chapter tax was paid.
- Initially, I thought that this was an error or that perhaps there was a glitch with the mass payment system, since the first submission of per capita fees was executed on December 24, 2017. However, after further investigation, it was determined that the 2018 chapter tax had not been paid.
- I immediately contacted Soror Desaree Boston regarding the non-payment of the 2018 per capita tax. We met on Tuesday, January 9th and submitted it through the online mass payment system.

Finance End of the Year Reports

- According to the instructions in the chapter report book, all finance reports should be submitted online by January 1st and considered late after February 1st, except for the W-9 forms, which are considered late after January 8th.
- I am pleased to report that on Friday, January 26th, the 2018 Chapter Budget Report, Statement of Financial Operation, and 2017 W-9 Forms, for services provided to the chapter that were \$600.00 or more, have been completed and submitted through Alpha Kappa Alpha's online finance reporting site.
- I would be remiss if I did not thank Sorors Terraine Gathers, LoElla Smalls, and LaQuinta Yates for assisting Soror D'Jaris Whipper-Lewis and going above and beyond the call of duty to make sure that these reports were completed accurately, so that they could be submitted electronically before the deadline of February 1, 2018.
- Additionally, as directed, a copy of the chapter's bylaws was sent electronically to Soror Sharon Brown-Harriott, South Atlantic Regional Director.
- With regards to the W-9 forms, please note that Soror Desaree Boston, Tamiochous, will have them available and completed by anyone that provides service to the chapter that is \$600.00 or more. This will prevent us from having to track the service providers down at the end of the year.

Committee Chairmen Online Report Submission

- Committee Chairmen online report submission is in place. The Technology Committee has created folders for each committee so that all chairmen can submit signed committee reports.
 - On Thursday, January 11th, committee chairmen met with Sorors Dena Magwood, Morgan Curry (Technology Chairman) and Camille Toliver (Technology Co-Chairman), and me, at the AKA Building, for an overview session that included training of the chapter's online report submission.
- The online report submission will allow immediate access to all committee reports. Please note that committee chairmen must still submit six signed copies to the Philacter, Soror LaTarsha Asby.

Upcoming Online Payment Center

- I am excited about the chapter's online payment processing center that is in its beginning stages.
- The PayPal accounts have been set up by the Tamiochous and Anti-Tamiochous for the general and housing accounts.
- The Technology Chairman and Co-Chairman are currently working on making the payment center a secure mechanism before it is launched. Additionally, they are working with Twenty Pearls Foundation to set up a link, so that sorors will be able to submit fees to the Foundation.

Constant Contact

- I hope that you will agree with me that this chapter is staying connected with "Constant Contact"!
- It is my goal to make sure that the messages are short, clear, concise, and easy to manage. I wanted to avoid messages getting "drowned" within the email and help us to stay on top of important information.

Housing Update

- On Friday, January 19th, Sorors Margaret J. Thomas (Housing Chairman), Thuane B.
 Fielding (Housing Co-Chairman), Dena G. Magwood (Anti-Basileus), and I met with Mr.
 Scott Dow of Dow Construction, Inc. with regards to external building renovation concerns
 that were identified. Mr. Dow ensured us that all of the concerns would be immediately
 addressed.
- In addition, we did a thorough walk-through of the building to show Mr. Dow the areas inside that need renovations. He will provide a SOW (scope of work) to the Housing Chairman/Co-Chairman once available.
